Information Technology Purchases

We are moving forward with the purchase of a new server. We are going over the specs with Monarch Security and they will be doing the installation.

ERAP (Emergency Rental Assistance Program) update

St. Mary's County has been awarded \$1,400,000 for ERAP 2. Funds are allegedly pending in the Comptrollers General Accounting Division Online Portal, coming from the State to St. Mary's County. Funds will then flow from St. Mary's County to HASMC.

- As of October 25, 2022 we have received 1510 applications
- As of October 25, 2022 we have dispersed \$4,619,122 in ERAP funds

Behavioral Health & COVID Services HUB

Phase 2 work is nearing completion; Phase 3 is TBD.

Indian Bridge Update

We have received an offer from Conifer to purchase Indian Bridge. No contracts have been signed as of yet.

Fox Chase Village aka Admiral's Landing Apartments

Osprey went to closing on September 29, 2022. Housing Authority is to provide referrals.

Victory Woods, Phase II

- On September 27, 2022, Sara Asgari from Victory Housing requested a meeting with Shawn Kingston & Anita Jones to discuss; they have been working on this quite some time with Dennis and have been moving forward based on those discussions.
- September 22, 2022: They are currently in discussions with the Archdiocese and the local parish regarding site control and will be preparing their CDA application once they have an agreement in place.
- Victory Housing has submitted an appeal letter to METCOM regarding the \$1.3M capital contribution charge

 Also submitted comments regarding the proposed Equivalent Dwelling Unit table update, which would impact fees on Victory Woods I and II

Valley Drive Estates

- On September 27, 2022 it was announced by DHCD that Pax Development, LLC received a 9% Tax Credit Award
 - Foundation Development Group, LLC and Pax Development submitted an LIHTC application to renovate 38 two- and three-bedroom townhomes which would be available for occupancy in early 2024
 - They have asked HASMC to refer qualified residents and to assist with marketing efforts

Villas at Lexwood

- On September 27, 2022, it was announced by DHCD that Green Street Housing received twinned 9% & 4% Tax Credit Awards
 - Greenstreet Housing submitted an application for new construction funding to DHCD on 05/04/2022
 - 40 unit affordable, energy efficient and quality rental housing development on a 3.961-acre parcel of land located on Lexwood Drive across from Lexwood Apartments
