St. Mary's County has been awarded \$1,400,000 for ERAP 2. As of January 24, 2023, we have received 1,510 applications for the entire program. As of January 24, 2023, we have dispersed \$4,383,921 in ERAP 1 funds and \$626,083 in ERAP 2 funds. We have been given until 2025 to spend the ERAP money.
