ERAP (Emergency Rental Assistance Program) Update

St. Mary's County has been awarded \$1,400,000 for ERAP 2. As of January 24, 2023 we have received 1,510 applications for the entire program. As of March 22, 2023 we have dispersed \$4,383,921 in ERAP 1 funds and \$716,126.66 in ERAP 2 funds. The remaining balance for ERAP 2 is \$683,873.34. Applications are currently being accepted with a quick turn-around for fund distribution.
